PRESIDENT'S COMMENTS

Bill noted that Drivers' School had a great turnout. May HPR race has about 100 entries so far.

MINUTES

A motion was made & seconded to approve the prior meeting's minutes as published; unanimous vote.

TREASURER'S REPORT

Ed noted that Drivers' School came in with about a \$950 loss compared to a budgeted loss of \$3300. 344 paid memberships are slightly behind same point of 2012. 2012 tax return is in process to be IRS compliant.

CHIEFS' REPORTS

GRID/FLAGGING & COMMUNICATION

Ken Tisdale reported that for the May HPR race, Grid is staffed, but more Safety Marshalls are needed. Tony Peak noted that RMVR requires a valid driver's license for ANY on track driving in ANY capacity (racing, lunch rides, driving to corners, etc). It was suggested that all RMVR documents (liability releases, entries, etc.) be reviewed to include acknowledgement that a valid license exists. Bill Fleming will contact Heacock Insurance to inquire as to what they recommend.

COLORADO MOTORSPORTS COUNCIL

Mark Robinson reported that a meeting has been scheduled for June 12th for the current CMC member clubs to vote on dissolution of the Council. Any remaining funds are to be donated to Cerebral Palsy of Colorado.

MARKETING DISCUSSION

Ken Tisdale recommended a business card template be created with RMVR's 2014 schedule & contact info for handouts by any members as a recruiting tool. They should be available as soon as the schedule is set. Ken has distributed more Apex magazines to Sports Car Craftsmen, Race Kraft, and Thomas Vintage Motors.

May HPR Race Chair Graham Nessel has recruited a sports writer to cover the event for distribution to magazines.

FUEL CELL PROPOSAL

No one was available to present last month's fuel cell proposal's second reading.

OPEN DISCUSSION

As post- PPIR Drivers' School feedback, Tony Peak noted that PPIR will be designating specific RV parking so non-RV users will not be tying up those spaces at future events. No pets are allowed in PPIR buildings, as per posted signs.
