APPLICATION FOR CAR ELIGIBILITY

For Early Production, Formula, and Sports Racer Cars

This Application form is to obtain an RMVR Logbook and RMVR car number for most RMVR eligible cars. (For cars prepared to the 1981 specifications, please consult the club's website for the application specific to those cars.)

RMVR eligibility requirements are generally based on the 1959, 1967, 1972 SCCA General Competition Rules (GCR), the associated PCS (Production Car Specifications) and the exceptions to these rules allowed by RMVR. Complete and current RMVR exceptions are published on www.rmvr.com under "Rules and Regulations". **Please note that it is the car owner's responsibility to read and understand these rules before constructing or buying a racecar. Buying a car with an existing RMVR log book does not insure the car's compliance to the rules nor relieve the buyer from complying with the rules.** Willful misrepresentation of the cars authenticity or preparation could result in the loss of RMVR membership.

Cars that aren't fully compliant with the rules (but are potentially so) may be issued a provisional log book, with a grace period to make corrections.

Please contact the appropriate member of the Eligibility Team or the Eligibility Team Chairman if you have questions regarding the car's eligibility. Any Team member is available to help guide you through the eligibility process.

Attach four 3" X 5" color photographs; 2 showing a three quarter front view and 2 showing a three quarter rear view of the car, to the completed application. One set of these photos will be kept in the car's file and the other used in the car's log book. Applications submitted without photos will be returned.

Mail the completed application to the appropriate Eligibility Team member listed below. If you have questions about where to send the application call Mark Robinson (303) 364-8726. The team will review your application and contact you regarding their decision or questions they have about the car. All acceptances are contingent on an inspection of the car to assure its compliance with the rules.
