CHIEFS AND SPECIALTY REPORT

CAMA Chief:

HPR Financial Results: Weekend usage increase back to levels from 2012 at HPR lifting revenue streams. Weekday use is still down to 2013 levels. But lapping business continues to increase. Overall 2014 revenue levels will fall short of 2012 but expense reductions helped return the profit margins to levels seen in 2012

FUTURE PROJECTS: CAMA has developed a list of future projects and is investigating the feasibility of each. The list includes garages and rest rooms, corner station lights and cameras paving the entry road and completing the paddock fencing. Of these only the day garages are seen as revenue enhancements.

ROLLBACK TOW TRUCK AND FIRE SUPPRESSION EQUIPMENT:

HPR has purchased Jeff Chase's rollback tow truck to complement the existing hook tow truck.

HPR has also purchased a fire suppression equipment skid from Dave Baker, to be installed on the existing hook truck. Both towing services and firefighting services will be offered as an option next year.

Towing service costs for HPR \$70.00 an hour with driver. \$100.00 an hour with driver and ride along firefighter/paramedic.

Discussion to change charges from per person to per car. Board recommended that the idea be brought up to CAMA for consideration. Rather than a per driver charge there would be a per car charge with the limit being 2 drivers per car maximum.
